Finding a quorum present and finding this regularly scheduled meeting of the Arch Hurley Conservancy District's Board of Directors duly advertised, as required by statute, President Lopez called this meeting to order at 9:10 a.m. in the District Office.

MANAGER'S REPORT

Today the Conchas Lake elevation is at 4,174.5 feet. Last year at this time the elevation of Conchas Lake was 4,185.0 feet. Conchas Lake received 989 acre feet of inflow for the month of February. The evaporation and other losses were 1,370 acre feet. The March snow pack on the Canadian River Basin is below the average so far this year at 94% of average through February. Last year at this time the snotel gauges were at 113%.

On February 19th, we mailed 15 letters to Class A landowners that are 3 years or more delinquent in assessments. The letter gives the landowners 60 days to bring their assessment current or Arch Hurley will file a lien on the property.

On March 4th, we mailed the assessments to all of the Class A landowners.

We are currently advertising for the office/finance manager position at Arch Hurley. Interested individuals can pick up anytime during office hours.

Arch Hurley received \$100,000 this year in Capital Outlay funding from Senator Woods and Representative Chatfield. The governor has until tomorrow at noon to sign the bill.

The men have been working on the maintenance repair list getting ready for the 2020 irrigation season. We have cleaned out several laterals on the Conchas side and will move over to the Hudson side whenever we are finished.

REVIEW CONCHAS LAKE ELEVATION AND WATER ALLOCATION

Manager McCasland stated that the elevation of Conchas Lake is 4,174.4. Director Mitchell made the motion to not allocate any additional water at this time. The motion was seconded by Director Perkins. Motion carried 4-0.

REVIEW OF LEGISLATIVE CAPITAL OUTLAY FOR ARCH HURLEY

Manager McCasland reported Arch Hurley has submitted Capital Appropriations Bond Questionnaire and is waiting to be approved \$100,000 in capital outlay from State Legislators.

NM PERA CHANGES ON EMPLOYEE AND EMPOYER WITHHOLDING

Manager McCasland reported on Senate Bill 72 stating the increase to employee and employer percentages to take effect July 1, 2022.

TUCUMCARI LAKE UPDATE

Manager McCasland reported entities involved with the Tucumcari Lake Project meet on March 11, 2020. They are moving forward with the project of placing water in the lake during the 4 month bird migration season and the removal of salt cedars. The next meeting is May 19 and 20, 2020.

APPROVE FIRST QUARTER FINANCIAL STATEMENT TO DFA

APPROVE RESOLUTION 2021-003 AHCD BUDGET FOR N.M. PROPERTY TAX DEPARTMENT TO ESTABLISH MILLS

Director Mitchell made the motion to approve Resolution 2021-003 AHCD Budget for N.M. Property Tax Department to establish mills. The motion was seconded by Director Perkins. Motion carried 4-0.

The 2021 budget is completed. Fund 1 and 3 remained the same as last year. Those are budgeted at \$16K and \$60K.

Fund 2 has an overall increase of 2.9% over last year's budget which equates to a \$50,825 increase. This is primarily salaries and wages and withholdings, with is a 5% increase in that line item, this is to comply with the new minimum wage law. The employee health insurance is increasing by 3% as well. Chemical Control was also increased by \$10,000 for a total of \$40K. Most of the other line item expenditures remained flat.

To cover the budget increase, we raised the assessments by \$1.00 to \$16.00 per acre and increased the water delivery fee to \$12.00.

The minimum wage in 2021 will increase to \$10.50, 2022 it goes to \$11.00 and 2023 it is \$12.00. I think we all know that every year a lawmaker will proposes a bill to raise the minimum wage to \$15.00. The Governor is also pushing for the \$15.00 minimum wage.

APPROVE CHANGE TO AHCD PERSONNEL HANDBOOK, POLICY#505 SMOKING

Director Griffiths made the motion to approve AHCD Personnel Handbook, Policy #505 Smoking. The motion was seconded by Director Perkins. Motion carried 4-0.
